Dear Gordon Memorial Award Committee:

It is my honor to again nominate Michael A. Embry, Sr., RHU, for the Harold R. Gordon Memorial Award. Mike has touched many people throughout our industry and beyond. In speaking with others about his influence on their lives and businesses, I have added two additional letters of recommendation to last year's submission. Those letters are from long-time NABIP member, Tony DeRico, whom Mike has mentored for several years, and Donald Eason, President of the CURE, the Center for Urban Renewal and Education, based in Washington, D.C.

As testified in Mr. Eason's letter, Mike supports many non-profit, community organizations including CURE, Faith-Wins and Embrace Grace. "Mike Embry is exemplary, often going under the radar with his unwavering support for causes he believes in," stated Mr. Eason. "These qualities align with the award's emphasis on selfless contributions that extend beyond professional obligations."

As a NAHU/NABIP member for over three decades, Mike has given his heart and soul to defending and improving the insurance industry. He is the quintessential servant leader, who has mentored many individuals, including myself.

A member since 1992, Mike's leadership in the organization began when he joined the Board of Directors for the Metro Detroit AHU chapter as Legislative Chair in 1997. Mike is what some people might call a "leg junkie" and took to this position quickly and effectively. He has attended nearly every Capitol Conference since 1997, while also actively lobbying for free market health care in Lansing, Michigan, alongside the Michigan delegation. In 2011, he received the Legislative Excellence Award for his ongoing involvement in the association's legislative efforts.

Mike has held leadership positions at every level of NAHU/NABIP. In 2000, he was elected President of Metro Detroit AHU, which was followed by being elected Secretary of Michigan AHU (MAHU) in 2003. He led MAHU as President in 2006-2007. In total, Mike served for 11 years on the Metro Detroit board and eight years on the Michigan board of directors. For this work, he received the NAHU Distinguished Service Award in 2002.

Mike then had the desire to serve at a higher level and served as the Region III HUPAC Chair for four consecutive years. After serving as the Region III HUPAC Chair, Mike was elected Region III Regional Vice President in 2010. During his three years as RVP, Mike traveled extensively throughout the six-state region. He was instrumental in starting the first chapter in the State of West Virginia.

In his region he received additional accolades. Due to his work and leadership on behalf of the Kentucky AHU, Mike was commissioned by Kentucky Governor Steven Beshear, into The Honorable Order of Kentucky Colonels in 2012. By proclamation, "Kentucky Colonels are unwavering in devotion to faith, family, commonwealth, and country. Passionate about being compassionate. Proud leaders who are gentle but strong in will and commitment."

For his stellar work within Region III, Mike received the Linda Erlenbach Region III Lifetime Leadership Achievement Award in 2019, which is Region III's top honor.

Mike's passion for service and commitment to NAHU and the employee benefits industry carried him to being elected NAHU Secretary in 2014, at the annual convention in Scottsdale. During his years on the Board of Trustees, he helped craft our vision for the future via the Vision 2020 Strategic Planning document. He also worked with other board members on policies which would ensure the financial viability of our organization and that future leadership would have a pathway to success.

At the annual convention in Orlando in 2017, Mike was sworn-in as NAHU President. During his term, he traveled across the country, visiting chapters and sharing the NAHU vision and value of membership. His passion for issues surrounding legislation, both state and national, was a centerpiece of his conversations. His motto, "Teamwork makes the dream work" was evident as he inspired members to become active in leadership and invited non-members to join the NAHU family.

After leaving the board of trustees, Mike has remained active with NABIP and continues to serve at a national level on the Governance Committee.

Mike is a person that leads by example. He has been a member of Leading Producer's Round Table since 2000, and a Soaring Eagle Qualifier since the inception of the program in 2011. He continues to be a Lifetime and Qualifying LPRT member. He has also been a contributor to the Michigan PAC as well as HUPAC, now NABIP PAC, for over 24 years. He received the Spirit of HUPAC Award in 2016. In 2017, 2019 and 2020, he received the Mike D. Grey HUPAC Award for being the association's top contributor. Mike has always answered the call when asked to support or sponsor a PAC event.

Mike also supports the insurance industry in Michigan by serving on the advisory board of several local insurance carriers including Blue Cross and Blue Shield of Michigan. He is also an active advisory council member for the Michigan Business and Professional Association, which supports the statewide business community.

He has many passions beyond NAHU/NABIP, including family, community, and faith. His fundraising efforts on behalf of the Multiple Sclerosis Society resulted in being named the organization's top fund raiser on multiple occasions. Following his passion for politics, Mike is involved with the Michigan Republican Party, Lincoln Club of Macomb County, and has worked on the political campaigns for numerous conservative candidates.

Mike is a man of great faith, which drives his ethics in both his business and personal life. He is very involved in his church, The Church of Christ, as well as the Church of Christ Care Center Foundation. Mike's mother, Carolyn, was a resident of the care center after he and his wife were no longer able to care for her in their home. He is on the Board of Directors of the Care Center Foundation. According to Doug Edwards, Executive Vice President/Philanthropy, "He has been one of our most active members, has participated in many of our projects and has been a very generous donor to our organization."

Mike would likely say that his greatest personal accomplishment is receiving his Thirty-Year Medallion from Alcoholics Anonymous. This milestone has taken personal fortitude and faith, like no other accomplishment. He continually uses this as a platform to encourage and guide others on their personal path to sobriety. His example has undoubtedly saved may people from lives of chaos and hardship.

Also on a personal side, Mike has two adult children and four beautiful grandchildren. He enjoys spending time with them when he is not traveling, boating, or hunting. In the fall, you will often find him "up a tree" in Northern Michigan, hunting the illusive white tail deer. He and his wife, Jeanne, reside in Chesterfield Township, Michigan, but are "snowbirds" spending much of the winter months in Arizona. While in Arizona, Mike still dedicates much of his time to serving his clients.

To me personally, Mike has been a lifelong mentor and friend. I have worked for his agency, Comprehensive Benefits, Inc., for nearly 24 years. During that time, he has inspired me to always work in the best interest of our clients, putting their needs before the monetary rewards offered by carriers. I have personally witnessed his integrity, generosity, and commitment to excellent in everything he does. In selling the agency to Risk Strategies in 2024, Mike negotiated to protect both his clients and his long-term employees.

The National Association of Benefits and Insurance Professionals and every person he touches have benefited from the efforts he has put into moving the employee benefits industry forward. For these efforts and many more, it is my honor to nominate Michael A. Embry, Sr., RHU, for our NABIP's highest recognition, the Harold R. Gordon Memorial Award.
