Rusty entered the insurance industry in 1993 after a 12-year career in the grocery industry. After a short 3 year span of selling Medicare Advantage products for PacifiCare of Texas he was given the opportunity to develop a vision HMO product for Eye Care Centers of America where he excelled at the group product level. Realizing the need to connect with more insurance agents, he became a member of NAHU 1998 but quickly realized the association was more than he ever imagined. He immediately became involved serving various committee roles for his local chapter in San Antonio which led to his eventual presidency in 2005. During his presidency, Rusty felt the need to give back to the community. He and his wife, Lori, adopted an inner-city school, Douglass Academy, where they were instrumental in providing several programs such as a mentor reading club, made up of SAAHU members, who read to students each Friday. Douglass Academy underwent construction to expand to accept more grade levels however funding was barely enough to build out the school.

Through Rusty's efforts, the association assisted the school by spending several weekends painting of the interior of the school which was accidentally left out of the district's budget. Rusty also raised the funds to place picnic tables in the courtyard so students could enjoy eating their lunch outdoors. He and his wife also organized efforts to raise money to purchase grade level library books and spearheaded the donation of 2500 books by a local publishing company. For his efforts he was awarded the chapters Underwriter of the Year Award in 2007 and the Dave Clark Lifetime Achievement Award in 2010.

Rusty also served at the state level in Texas, becoming President in 2009 when the chapter won numerous awards. Rusty introduced forward thinking strategic planning that not only focused on the immediate needs of the chapter but established a parking lot of long-term goals to strive for. In addition, Rusty re-resurrected the states golf tournament, held in conjunction with their annual convention and was able to raise over Twenty Thousand Dollars for the Treehouse Day School, a center for preschool aged children with autistic needs. For his leadership efforts he was awarded the NAHU Distinguished Service Award and NAHU Presidential Citation. Rusty is also the recipient of the 2012 Shirley Hutzler Legislative Excellence Award, the 2010 Ken Martin Excellence in Communication Award. In 2016 Rusty Received the highest honor bestowed upon a member of Texas, the Hollis Roberson Award.

Rusty has been at the forefront of legislation at both the local, state and national level attending every TAHU Legislative day and Capitol Conference since 2004. He was also a panelist in, then Governor Perry's Think Tank meeting regarding healthcare options and trends for Texas. He was also a guest speaker in a mock congressional hearing of a joint

effort of the Austin Community College District and the University of Texas. In 2010 Rusty also testified with Beth Ashmore in front of the Texas Senate Commission on the State Affairs regarding the role of the insurance agent and the value they bring to public they serve.

With the introduction of the Affordable Care Act, Rusty created continuing education courses that broke down the bill, and eventually the law, and taught over 200 hours to association chapters, employer groups, their clients, and Chamber of Commerce chapters throughout the state. Constantly giving back to the industry, Rusty has taught over 100 hours of Ethics CE classes and over 200 hours of various other topics.

In 2013 Rusty was elected by the membership to serve as the NAHU Regional Vice President followed by Secretary, Vice President, President Elect and served as President of NAHU in 2018-2019. In his run for Secretary, Rusty ran on the platform that NAHU needed to begin to thing long term as well as find ways to better communicate with their members. As Secretery, Rusty immediately began to work with Jim Stenger, Mike Embry and then CEO Janet Trautwein on Vision 2020, a look at what NAHU needed to be focused on leading up to 1-1-2020. The strategic plan looked at why NAHU exists and how we can deliver on our needs of our members by ensuring the association was moving in the direction of our industry. Vision 2020 was put into place in 2017 that focused on 3 key items, Legislation, Membership and Professional Development, and laid the groundwork for the years to come.

Rusty also saw the need to include our Professional Development chair as part of the BOT to ensure member training was included in the decisions of the board.

In line with long term thinking, during his presidency Rusty developed the futures task force, designed at looking at where our industry would be in the next 5-10 years and what the association needed to do to ensure we continued to meet the needs of our members. The futures task for was made up of professionals from across the country in every aspect of our industry. Their findings were presented to the BOT in June 2019 and were a focal point in the BOT's development of the 2025 strategic plan.

Rusty also worked with staff to expand the NAHU mobile app as a way of communicating with our membership with immediate results. The app allowed NAHU to send out targeted messages to specific regions, announcements of upcoming events, weekly legislative updates and more. Rusty worked well past his presidency to continue to develop the app until it was eventually replaced in 2024.

After his presidency, Rusty also continued to serve, now NABIP, facilitating local and state chapters strategic planning meetings. His forward-thinking planning sessions are sought out by many chapters across the country and have helped struggling chapters restructure and reach new heights.

In 2021 Rusty established the Rusty Rice foundation which focuses on providing free eye examinations and free eyeglasses to children from disadvantaged backgrounds. He works with local schools and children's shelters to make sure that every child has an opportunity to succeed in school.

Rusty has been with Avesis LLC since September 2003 serving many roles. He is now the Director of Commercial Sales responsible for leading a team of Sales Managers across the US to meet their individual production goals. Rusty is also responsible for the Texas and Central US markets as well as focusing on National reinsurance opportunities. He is an 18 year member of the Leading Producer Round Table and Lifetime Qualifying - Carrier Golden Eagle.

Rusty lives in Boerne Texas with his Wife Lori, an insurance agent, and their 2 sons, Quinten and Skyler. Rusty's Daughter Morgan lives in Temple with her husband Derrick and Daughter Brazley and son Ledger. In his spare time you will either find him on the golf course or at his family ranch in South Texas where he has the opportunity to enjoy the outdoors with his family and friends.
