Legislative Council – Scott Wham (Chair)

 Expanding the conversation regarding "health care reform" to include a broader conversation about social determinants of health. Too often the discussion focuses solely on payers without a serious focus on what drives poor health in the first place. As the balance of power in D.C. shifts to democrats, we have to be able to give them programs we



support. Investments in addressing social determinants (nutrition, education, housing, community improvement, etc.) are an efficient way to achieve generational improvements in a population's health while simultaneously reducing the demand for medical services.

- Cross-collaboration between working groups to address state and federal legislative issues. Most notably, we formed a task force that leveraged expertise from a few different working groups to address Illinois' exploration into establishing a public option. This led to a BOT/Leg Council educational session on WA's public option.
- 3. Expanded lines of communication between the BOT, Leg Council, and prominent members to discuss potentially controversial legislative issues.
- 4. Obtained key clarification from the EEOC regarding Age Discrimination in ICHRAs.
- 5. Worked to ensure that our members' interests were represented in COVID-19 relief bill discussions.
